With regard to the Notification issued on 15th August 2025 by Telangana State Level Police Recruitment Board (TSLPRB) to fill up 118 vacancies of Assistant Public Prosecutors in Telangana State Prosecution Service through direct recruitment, Applications are invited from desirous and eligible Candidates through Online mode only in the prescribed proforma which will be made available on TSLPRB Website (www.tgprb.in) from 8 a m on 12th September onwards to 5 p m on 5th October 2025. Applications received through any other mode will not be accepted and will summarily be rejected. The details of the procedure for payment of Fee, filling up of Online Application and General Instructions are already mentioned in the detailed Notification dated 15th August 2025 and the same may be referred to.

Candidates with local candidature of Telangana State belonging to SC and ST Categories have to pay Rs.1,000/- towards Registration of the Application, Processing of Application, Conduct of Examination, Maintenance of Portal etc. All other Candidates have to pay Rs.2,000/- towards the same, as per the GO referred to above.

LEGAL ADVISORS, LEGAL COUNSELS, LAW OFFICERS CAN APPLY

Candidates who have practiced as an Advocate for not less than 3 years in the <u>Criminal Courts of Telangana State</u> and are now engaged as Legal Advisor, Legal Counsel or Law Officer in the State / Central Government Organizations, Public Sector Undertakings, Public Sector Banks and reputed Corporates as on the date of Notification are also eligible to apply. Such Candidates have to submit Letter / No Objection Certificate from the concerned Authorities of the above Organizations along with Certificate/s of practice for not less than three (3) years, in Criminal Courts in the State of Telangana issued by the local Bar Association (s) / presiding officer of the concerned Court(s) where the Candidate practiced.

SYLLABUS - CERTAIN CLARIFICATIONS / MINOR MODIFICATIONS

As per the request received from the Director of Prosecutions, Telangana State, the Candidates are hereby informed that in the Syllabus mentioned in Annexure-I of the Notification dated 15th August 2025, the following minor changes may please be noted –

In *a) Central Acts*, the existing entries at S Nos. *xxviii) The Limitation Act, 1963 and xxxiv) The Prevention of Food Adulteration Act, 1954* are now excluded from the Syllabus and in their place, the following are substituted:

xxviii) The Chit Funds Act, 1982 xxxiv) The Food Safety and Standards Act, 2006

Similarly, in *b*) *State Acts*, the existing entries at S No. *iv*) *The Telangana State Chit Funds Act*, 1971 and xi) *The Telangana State Preventive Detention Act*, 1970, are now excluded from the Syllabus and in their place, the following are substituted:

- iv) The Telangana Prevention of Ragging Act, 1997
- xi) The Telangana Prevention of Dangerous Activities of Bootleggers, Dacoits, Drug-Offenders, Goondas, Immoral Traffic Offenders and Land Grabbers Act, 1986

Candidates are advised to read the detailed Notification on the TSLPRB Website before filling the Online Application. Candidates should keep ready for uploading along with Online Application Form (a) soft copy of his / her passport size photo+signature combined in jpg format (File size min: 30 KB and max: 100 KB) and (b) the relevant certificates / documents in pdf format (each less than 1 MB in size), for uploading with the Application.

Candidates may contact Help Line Number shown on the Website (www.tgprb.in) to clarify doubts, if any, while filling up of the Online Application. After submitting the Online Application, Candidates have to take out a print-out of the finally submitted Online Application for future reference. **TSLPRB will not entertain any correspondence from any Candidate directly**.
